(This proposal would delete from the Constitution and Bylaws the mandated 10-yard tiebreaker in Regional and State Football Games. It is anticipated that the Football Advisory Committee will be recommending moving to the 25-yard tiebreaker.) **The SDL will vote yes on this proposal.**

4.03 Revision to Bylaw 207.B.(5) Sit Out Period (Action Item)

(This proposal would revise the language for the Sit Out Period. The changes would be implemented during the 2018-2019 school year.) **The SDL will vote yes on this proposal.**

4.04 Bylaw 1108 Delegated Powers Hurricane Harvey

(This proposal addresses the eligibility of athletes impacted by Hurricane Harvey and relocating to CIF member schools.) **The SDL will vote yes on this proposal.**

5.01 Bylaw 503.8 Administrative Supervision (Playoffs)

(This proposal would require all schools participating in Section playoffs to have administrative presence/representative at specific Section playoff events.)

5.02 Bylaw 3203.8.a Team Duals Wrestling Playoffs

(This proposal would change the structure of the wrestling team duals from a league based system to an enrollment based system. Implementation would be for 2017-2018.)

5.03 Bylaw 2800.5.a.3 Coed Team Tennis Playoffs

(This proposal would change the structure of the coed tennis playoffs from a league based system to an enrollment based system. Implementation would be for 2017-2018.)

5.04 Bylaw 2700.11.d Swimming and Diving Championships

(This proposal would change the structure of swimming and diving championships from one division to three divisions for boys and girls.)

5.05 Elimination of Bylaw 206.2

(The Uniform Administrative Oversight Penalty (CIF Bylaw 530.B.(1) was approved. The current Sac-Joaquin Bylaw (206.2) is less restrictive which takes the Section out of compliance. Thus, the Bylaw must be omitted.)

5.06 Election of Small, Medium and Large School Athletic Director Representatives (Deadline for nominations is Monday February 5, 2018. Large school AD rep DI and II; Medium School Rep DIII and IV; Small School Rep DV, VI, and VII. The positions are open for the 2018-2022 alignment.)

(This revision would clarify the athletic eligibility of International students who transfer without a valid change of residence.)

5.08 Elimination of Bylaw 1605 Basketball Coaching Box
